UPON the application of the Alberta Securities Commission ("ASC"); AND UPON reading the Affidavit of Kyle Schuh; AND UPON hearing from counsel for the ASC; AND UPON hearing from no one on behalf of the Respondent, David Michael Greene ("Respondent");

**IT IS HEREBY ORDERED THAT:**

1. Service of the Notice of Application, Affidavits of Kyle Schuh filed on May 21, 2020 and January 27, 2021, and Order for Service *ex juris* on the Respondent is deemed good and sufficient.

2. The Decision of the ASC dated June 18, 2010, levying an administrative penalty against the Respondent in the amount of \$2,000,000.00, and requiring the Respondent pay \$18,100.00 towards the costs of the ASC investigation, which was filed in this Action and became a Judgment of this Court against the Respondent on June 25, 2010 ("Judgment"), is hereby renewed for a further period of 10 years, and a new Judgment is granted to the ASC against the Respondent, pursuant to Rule 9.21 of the *Alberta Rules of Court*, for the amounts remaining due and unpaid on the Judgment, including interest and costs.
3. The Applicant is awarded costs of this Application in the amount of \$1,080.
4. Rule 9.4(2)(c) is hereby invoked.
